







FIBRE NETWORK TO YOUR HOME



Fibre communication network becomes available in your neighborhood!

Project for construction of fibre (optical) network is being implemented in municipalities of Galovac, Sukošan, Sveti Filip i Jakov and Škabrnja. The fibre network will connect private, business and public premises in so-called white areas of Galovac, Sukošan, Sveti Filip i Jakov and Škabrnja municipalities.

Project value is 51.257.449,78 HRK. It is 72,38% co-financed by grants from EU funds. It is planned the Project will be finished by the end of 2023.

If you wish that fibre network connection is installed to your premise, please read this leaflet which will give you instructions for delivery of consent for installation of fibre network connection to your premise.

What is possible with fibre network connection?


You can access internet with speeds of several hundreds megabits per second (Mbps), which can be increased up to one gigabit per second (Gbps) or even above. High speed internet surfing, watching a number of TV and video channels, home working, video-conferencing - these are the most important services that will be available, with increased quality and availability in comparison with existing services.


Who is the owner of fibre network and how services will be provided?

As opposed to majority of telecom networks owned by private operators, fibre network in the Project will remain in public ownership permanently. It will be owned by the municipalities implementing the Project, which is the similar case as for other public infrastructures (e.g., roads, water-supply). The services over the network will not be provided by the municipalities themselves, but the services will be provided by operators active in the telecom market. Users in premises will select any operator and service according to their preferences. The selected operator will then lease fibre network's capacity and connection to the premise, and start to provide services to the user. By this, the network will be open to all operators under the same conditions. Users will be able to choose from a number od services offered by several operators, which will certainly result with more favourable service quality and prices.

How is fibre network connection implemented on user premises?

In majority of cases aerial connections will be implemented, by hanging a fibre cable from the nearest pole in public area to user premise. Inside the premises, fibre sockets will be installed on suitable locations, according to users' preferences. In cases where aerial connections cannot be implemented, underground cable connections will be implemented, also according to users' preferences. As it is the case with whole fibre network, the user connections will be implemented by fibre (optical) cables. Fibre cables do not contain metal parts and do not produce electromagnetic (radio) waves.





Is installation of fibre connections to premises free?

The installation of fibre connections to premises is free for all users who give their consents for the installation.

When services over the fibre network will be offered by operators?

Construction of fibre network will begin during 2022. It is planned that all users will be able to take services over the fibre network till the end of 2023. The further notice on availability of the services will be given when they will be available.

CONSENT FOR INSTALLATION OF FIBRE NETWORK CONNECTION

By giving the consent for installation of fibre network connection you agree that fibre network connection is installed to your premise during the implementation of the Project. Your consent has to be delivered to municipality office in which your premise is located. Further instructions are given below.

You will settle details on installation of fibre network connection later with installation contractor. In case you deliver the consent, installation contractor will contact you before starting installation works on your premise. As a premise's owner you may specify any other person whom installation contractor will contact before starting installation works.

Owners of apartments in multi-dwelling premises shall also deliver their individual consents for installation of fibre network connections to their apartments. Additionally, a representatives of owners in multi-dwelling premise shall contact municipality office in which premise is located, to settle installation of the network within common parts of the premise.

How to complete the consent for installation of fibre network connection?

The consent form is printed on the next page. You must fill necessary data marked with 1, 2, 3 and 4 in the consent form on the next page:

- 1. Premise address (municipality, settlement, street and number).
- 2. Premise owner (name and surname, address). If there is more than one owner, all owners shall be specified. For apartment in multi-dwelling premises, owner(s) of apartment shall be specified. In case the owner is legal entity, its name shall be specified.
- 3. Contact for settling details on installation of fibre network connection (name and surname, phone). You can specify any other person instead of owner whom installation contractor will contact.
- 4. Date and signature of owner.

How the consent for installation of fibre network connection is to be delivered?

Completed consent forms shall be delivered by 31 December 2021 at latest.

Whom shall contact representatives of owners in multi-dwelling premises?

Representatives of owners in multi-dwelling premises shall additionally contact municipality office in which premise is located, by e-mail as given above. They shall specify address of the multi-dwelling premise (municipality, settlement, street and number) and representative's contact (name and surname, phone).

The process personal data is performed pursuant to Article 6.1.(e) of GDPR (exercise of official authority). The personal data will be stored permanently pursuant of processing of archive material. For installation of fibre network connections, municipalities of Galovac, Sukošan, Sveti Filip i Jakov and Škabrnja havinterest to share your personal data with installation contractors that will deploy fibre network connection to your premise. At any moment you have access, rectify and erase your personal data, right to object certain types of processing of your personal data, and right to restrict processing of your data. You can claim your rights for free by submitting request to GDPR officers in municipality in which premise is located. Upon receiving request, to municipalities can verify sender's identity.
